FILING FEE GUIDLINE

This guide will help in the assessing and calculating the fee relating to the registration/incorporation of new company, enhancement of authorized share capital of existing company, filing of annual or periodical returns filing of forms related to mortgage/charge/applications and other statutory forms and applications as required under Companies Act 2017 & The Companies Regulations, 2024.

There are two basic modes for the payment of the fee.

1. Online 2. Deposit of challan in bank.

ONLINE

In online fee payment which is hassle free, the applicant made payment of fee through credit card or ADC payment or Easy Paisa.

DEPOSIT OF CHALLAN IN BANK

In Deposit of the challan in bank applicant has to visit bank branch to make payment either system generated challan in eZfile with PSID with three counter portions in one challan or manual challan in eservices. In Manual Challan there are three copies of challan Original, Applicant, Bank, (Please note that original challan needs to filed with return in case of manual Challan) The 7th Schedule which is reproduced below shows the required filing of various returns in respect of their authorized share capital. Most of the fees of the returns are fixed with respect of the return like Annual returns, induction and cessation, Forms 10,16,17 and application for change of name, change in status, application of extension holding of AGM, etc. The filing fee of the Company incorporation depends upon how much authorize capital is decided by the sponsors/subscriber and fee for the increase in the authorize capital of the already incorporated company depends upon how much capital has enhanced in comparison of the capital before enhancement.

Provided further that no such fee shall be applicable on registration of an increase in authorized share capital of a transferee company after merger consequent to sanction of application for compromises, arrangements or reconstruction for merger of companies by the Commission pursuant to Section 279 to 282 or section 284 of the Act, to the extent of aggregate of authorized capital of the transferor and transferee companies.

Explanation.—For the purpose of calculation of fee for registration of an increase in the share capital of the company which has shifted from physical mode of filing to electronic mode of filing, the difference of fee shall be calculated on the basis of the rates applicable for electronic submission on the amount of capital before and after such increase:

Provided further that where a company to be formed has been notified by the Federal Government in the official Gazette to be wholly owned by it, a fee of Rs.10,000/- shall be charged irrespective of amount of share capital.

Filing fee along with late filing fee of the online return/form is calculated by the system automatically. If form/return is not available in online system then manual filing fee will be applicable.
