NOTIFICATION

S.R.O.1963(I)/2024.- In exercise of powers conferred by section 10 of the Securities and Exchange Commission of Pakistan Act, 1997 (XLII of 1997), the Securities and Exchange Commission of Pakistan ("the Commission"), in supersession of the its earlier notifications No. S.R.O. 603(I)/2021 dated May 25, 2021, and S.R.O. 1726(I)/2022 dated September 06, 2022, subject to such conditions and limitations as it may from time to time impose, hereby delegates the following powers and functions of the Commission to its Commissioner and the officers of the Corporate Registry Department, Licensing and Registration Division, namely:-

POWERS AND FUNCTIONS OF THE COMMISSION DELEGATED TO COMMISSIONER, LICENSING AND REGISTRATION DIVISION:

Powers and Functions in respect of companies other than listed companies unless otherwise specified below. - (Except for the companies involved in business of Insurance under the Insurance Ordinance, 2000 (XXXIX of 2000) and the Non-Banking Finance Companies or notified entities as referred to in Section 282A of the repealed Companies Ordinance, 1984 (XLVII of 1984).

In case, the post of Divisional Head (LRD)/Executive Director is vacant or he/she is not available at the place of posting due to any reason, the powers and functions delegated to him through this notification shall stand delegated to the Concerned Commissioner.

In case, the post of Registrar of Companies/Head of Department (CRD) is vacant, or he/she is unavailable or unable to perform his/her functions, the powers and functions delegated to him/her through this notification shall stand delegated to the Divisional Head (LRD).

This Notification shall not affect anything done, order made, application received, notification issued, show cause issued, circular made, proceedings commenced, penalties imposed and/or collected, sanction or exemption granted, approval made, fee directed or collected, directions given, investigation, inspection or inquiry conducted or any other action taken or done under or in pursuance to any previous notifications superseded or amended by this notification and shall be considered valid and under lawful authority.

Any pending proceedings under any previous Notifications shall stand transfer to the delegated authority provided in this Notification forthwith who shall proceed with the matter as it stands prior to the coming into effect of this Notification
