- 1. This Invitation to Bids follows the Procurement Notice (PN) **T#07(ii)/24-25** for the subject Project/Procurement which appeared on PPRA Website and two daily newspapers.
- 2. The Procuring Agency has reserved the funds for the procurement planned during the financial year 24-25. # A. INTRODUCTION




