1. This Invitation to Bids follows the Procurement Notice (PN) **T#12(v)/24-25** for the subject Project/Procurement which appeared on PPRA Website and two daily newspapers.
2. The Procuring Agency has reserved the funds for the procurement planned during the financial year 24-25. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Procurement of Software Subscription and Support renewal of IBM Guardium .
3. The SECP now invites sealed bids from eligible Suppliers for Procurement of Software Subscription and Support renewal of IBM Guardium .
4. The bidding shall be conducted in line with the Single Stage One Envelop procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time), and is open to all potential bidders.
